1. PROMOTER

Entries received outside the Promotional Period will not be accepted.

3. ELIGIBILITY

Entry is open to Australian residents aged 18 years and over.

Employees, contractors, directors and management of the Promoter, Deepwater Plaza retailers, participating agencies and companies directly associated with the Promotion, and their immediate family members, are not eligible to enter.

- gambling products;

- any other products or services that cannot legally form part of a trade promotion.

If a qualifying purchase is subsequently returned or refunded, the corresponding entry may be deemed invalid.

9. PRIZE POOL

15. VALIDITY OF ENTRIES

- uses automated entry methods;
- interferes with the fair operation of the Promotion; or
- otherwise engages in conduct that the Promoter reasonably considers inappropriate or contrary to the spirit of the Promotion.

Errors and omissions may be accepted at the Promoter's discretion.

16. TECHNICAL ISSUES

18. LIABILITY

To the extent permitted by law, the Promoter is not responsible for any loss, damage, injury or expense suffered or incurred by an entrant or winner in connection with the Promotion or acceptance or use of a prize, except where such loss, damage, injury or expense is caused by the Promoter's negligence or breach of law.

19. PRIVACY

The Promoter will collect entrants' personal information for the purpose of administering and conducting the Promotion, verifying entries, contacting winners and awarding prizes.
